Important Notes on Course Selection & Programme Logistics

COURSE SELECTION

CURRICULUM STRUCTURE: All courses are offered on credit basis. Candidates must complete eight courses by selecting two compulsory foundation courses (9 credits each), five elective courses (6 credits each), and one course for capstone experience (12 credits). Candidates have to complete a total of 60 credits for graduation.

Compulsory Foundation Courses and Elective Courses

1. Please refer to the [MBS Dates of Semesters 2026-27](#) for the course enrollment period, add/drop period, and assessment period. The finalized examination timetable will be available online in November 2026 and April 2027.
2. During the course enrollment period and add/drop period, students can attend classes without registration. If a course is shown as “Class has been closed” on HKU Portal, it means the course has reached maximum enrollment capacity. You are therefore advised to complete online course selection as soon as possible to finalize enrollment. Please contact the Centre at buddhism@hku.hk if you have difficulty enrolling in a course.
3. The enrollment of [BSTC8999 Capstone Experience: Dissertation](#) will only be approved in the second semester if student has fulfilled all the conditions. Please refer to the below timeline on Capstone Experience for more information.
4. Due to limited classroom capacity, students who wish to survey a course without official enrollment after the add/drop period must email the course instructor and copy buddhism@hku.hk as soon as possible. Sit-in request will be considered based on classroom seats availability.
5. Course selection is not automatic. Students must manually enroll in all courses, including the two compulsory foundation courses and the Capstone Experience course, on HKU Portal during the course enrollment period or add-drop period.

Capstone Experience

- The capstone experience is compulsory and can be conducted in the following forms:
 - Submission of a dissertation (BSTC8999); or
 - Completion of an additional elective course (BSTC8xxx) together with the submission of a portfolio.
- For submission of portfolio, the completion of an additional elective course should be done in the final year. Submission of portfolio and dissertation should also be done in the final year of study.

Please refer to the capstone timeline below for final year students:

Date	Students concerned	Details
Sept to mid-Nov 2026	For ALL final year students	To consider whether to do (i) Dissertation or (ii) Portfolio
November 15, 2026	ONLY for students who plan to do Dissertation	Deadline to reach out and submit complete dissertation proposals to potential supervisors for their consideration.
December 31, 2026	ONLY for students who plan to do Dissertation	Final day to receive written confirmation from a potential dissertation supervisor. Students who have not secured a supervisor by this date should consider their dissertation application unsuccessful and must proceed with the “Portfolio” option.
January 10, 2027	For ALL final year students	Submission of the <u>“Capstone Experience Application Form”</u> along with the following: For students who got confirmation from supervisors to do Dissertation: -- submission of <u>full proposal</u> and the <u>teacher's written endorsement on the proposal and supervision</u> For students who do Portfolio: -- indicate ONE area of interest among the choices available in the application form -- Portfolio topic is not needed in this stage and will be developed after supervisor is assigned to the student

January 31, 2027	ONLY for students who do Portfolio	Final day to receive notification on the assignment of supervisors.
January to July 2027	For ALL final year students	To work on the dissertation or portfolio under supervision of the assigned supervisor. Students are expected to reach out to their supervisors proactively for supervision.
July 31, 2027	For ALL final year students	Submission deadline of both Dissertation and Portfolio.

3. Enrollment and add/drop of Capstone Experience must be done through HKU Portal during the course enrollment period or add-drop period.
